




p. The Authors of Trust shall have power to Nominate (co-opt) Additional Trustees and Trustees so co-opted / nominated for life, shall hold office for life. r. All the powers and functions of The Chairman cum Trustee and Managing Trustee / Trustee shall be exercised by concurrence between the said two functionaries. Any decision or exercise of power shall not be done in isolation.
